<u>Domestic Abuse Review Committee</u> (DARC) Results

- 955 total reports in 2018 compared to 773 in 2017 a 23.5% increase
 - o 76 cases or 7.96% are still open for follow up
 - o 29 cases or 3.04% have an outstanding warrant
- 586 arrests in 2018 compared to 434 arrests in 2017 a 35% increase
 - 9 or 1.54 % of all arrests made 2018 were dual arrests compared to 9 in 2017 a 0% increase
 - 452 or 77.13% of the arrests were male in 2018 compared to 342 or 78.8% in 2017
 - 134 or 22.87% of the arrests were female in 2018 compared to 92 or 21.2% in 2017
- 29.95% of all cases in 2018 involved children compared to 28.59% in 2017
 - o 266 children witnessed domestic abuse in 2018 compared to 190 in 2017
 - 81.08% charging rate for child abuse when children were direct witnesses to abuse in 2018 compared to 71.60% in 2017
- 46.18% of all cases in 2018 involved repeat offenders compared to 43.34% in 2017
- Assault was the number one offense type in 2018 (31.27%) with other (23.78%) number two and harassment (22.57%) number three.
 - Weapons were involved in only .09% of the 2018 cases, a 66.6% decrease from 2017
 - Violations of Protection Order accounted for 30.26% of the 2018 cases compared to 27.81% in 2017
 - 57 cases in 2018 involved strangulation and 2nd degree assault was charged in 100% compared to 52 cases in 2017 with 90.38% being charged with 2nd degree assault
- The victim was the reporting parting in 53.85% of the 2018 cases compared to 56.94% in 2017
 - Third party reporting was down .30% in 2018
 - o Family/friends reporting was up 2.71% in 2018
 - Other reporting party was down .10% in 2018
 - Suspect reporting was up .56% in 2018
- Friday was the busiest day for reporting domestic violence in 2018 (16.1% of the cases)

- Saturday was the second busiest day in 2018 (15.3% of the cases)
- o In 2017 Sunday was the busiest day and Saturday was the second busiest

• 2017 Case disposition Data

- o 8.25% of all 2018 felony arrest dismissed compared to 11.4% in 2017
- o 69.07% entered a plea agreement in 2018 felony cases compared to 65.79% in 2017
- o 18.85% of all 2018 misdemeanor arrests dismissed compared to 21.81% in 2017
- o 38.46% entered a plea agreement in 2018 misdemeanor cases compared to 47.33% in 2017
