# What is a CIP?

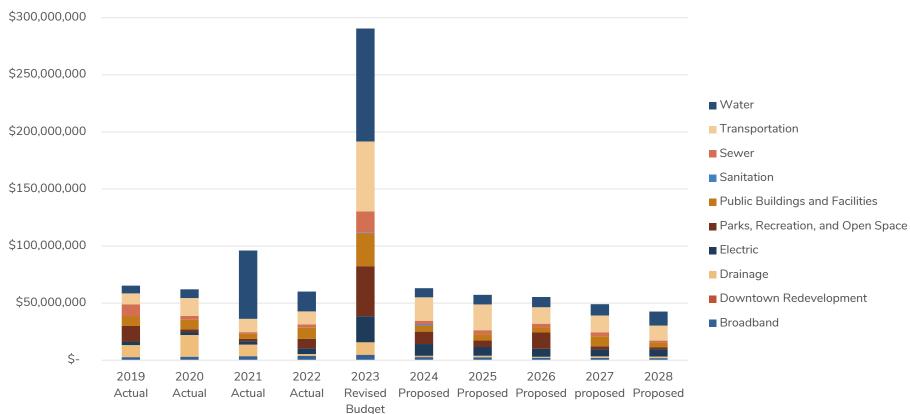
- <u>Capital Improvement Plan</u>
- Shows the City's infrastructure needs over the next 5 years
- Includes infrastructure with
  - Minimum life expectancy of 5 years
  - Minimum cost of \$10,000
- Projects funded in 2024 are included in the 2024 budget if approved
- Years 2025-28 show the City's plan for the future

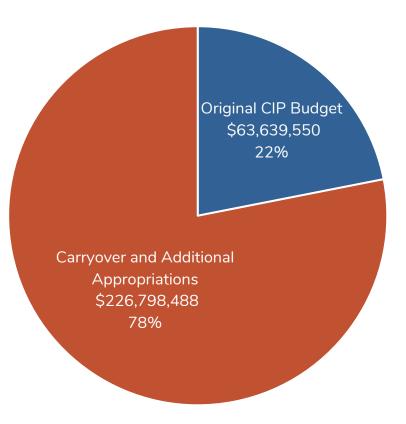

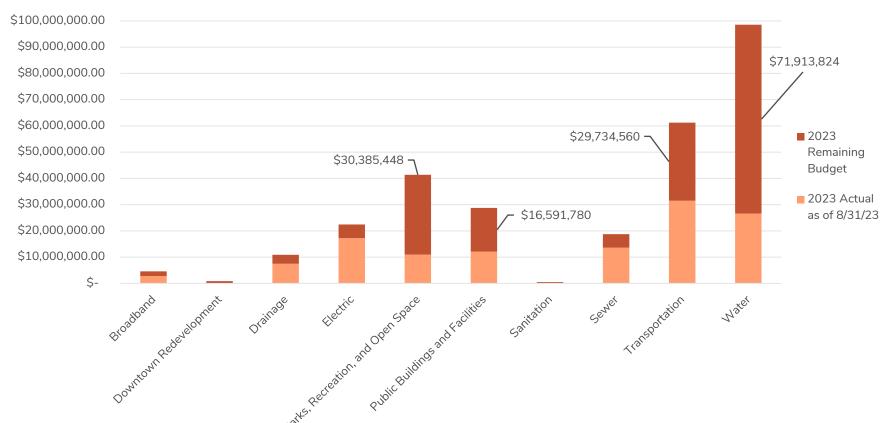

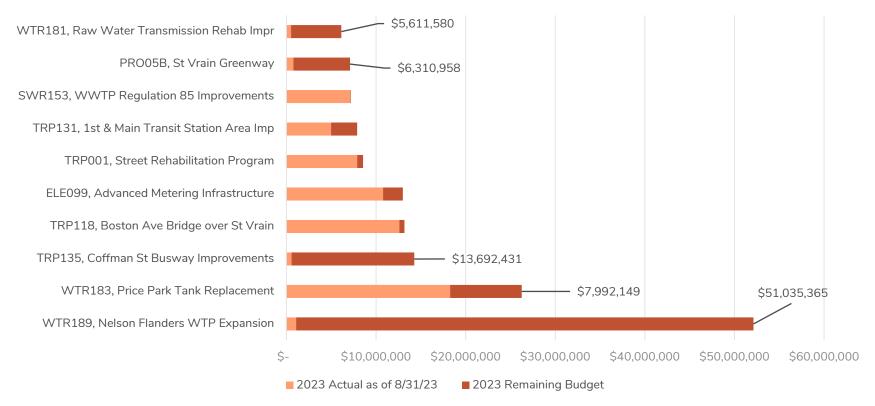

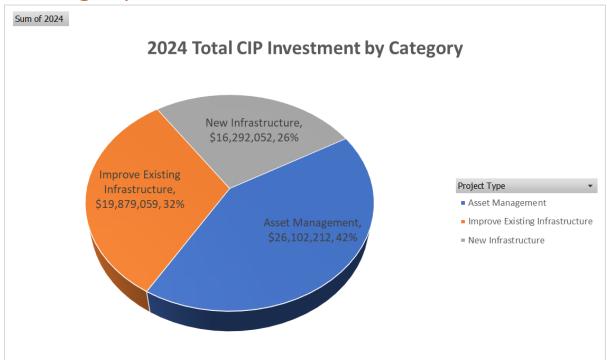

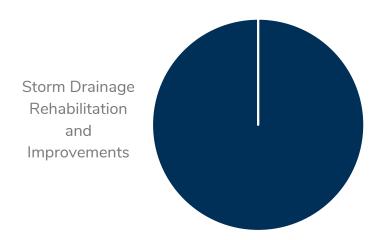

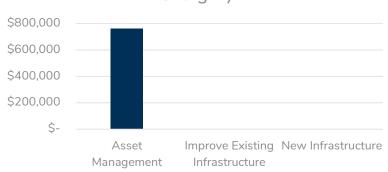

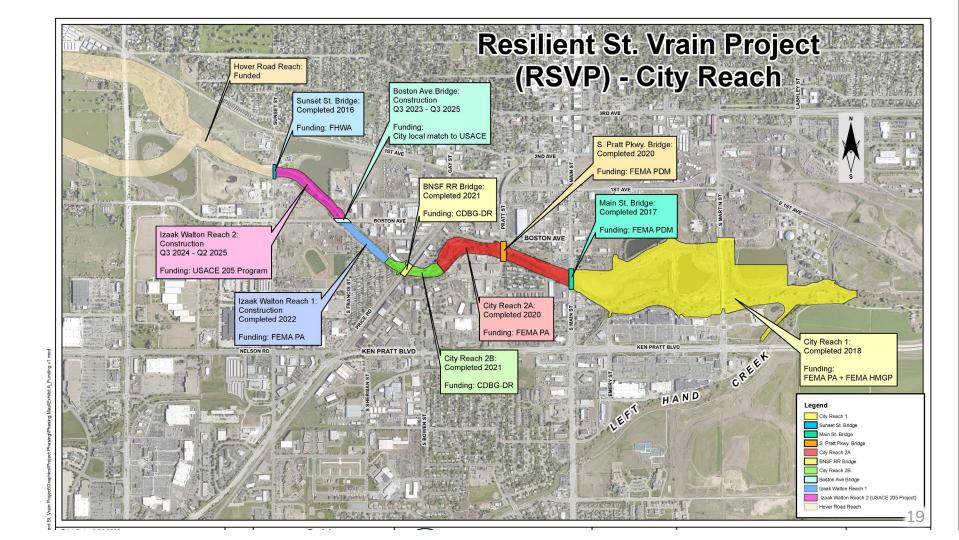


#### 2019 - 2028 Drainage CIP Trend

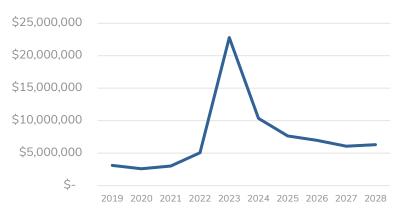

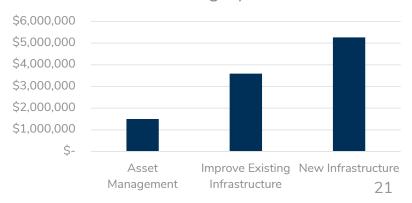

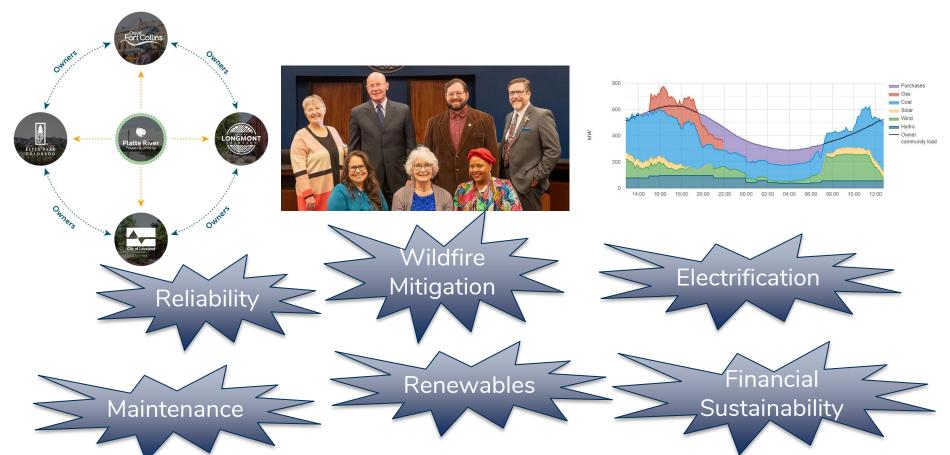
#### 2019 - 2028 Electric CIP Trend

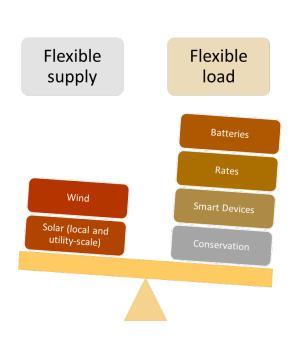

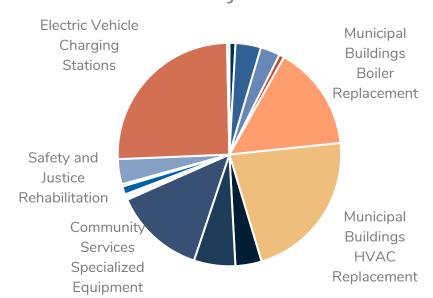

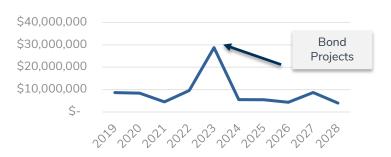

#### 2023 Update - \$204k grant from State of Colorado

Level 3 Charging Stations (quick charging – 80% power in 15 minutes)

#### Level 2 Charging Stations (4-6 hour charging time)

- Waste Services (ADA compliant)
- Fleet Services
- Service Center
- Parks Maintenance Facility

2024 CIP- 15 Level 2 Charging Stations

**2025 CIP**- 10 Level 2 Charging Stations

**2026 CIP**- Re-assess and perhaps 5 Level 2 Charging Stations

**2027 CIP** – Level 3 Charging Station for Public Safety

#### Other notes

Many vehicles are on order, but orders have been cancelled or have long lead times

All new Public Safety patrol vehicles are hybrid

Working with CDOT on cooperative agreements for charging stations

Plan to apply for additional grant funds from State of Colorado

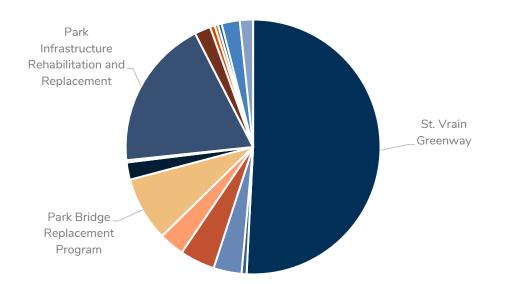

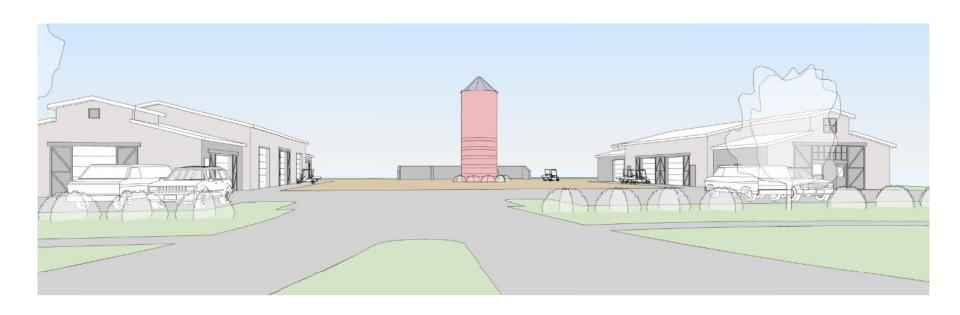
#### 2019 - 2028 Parks CIP Trend

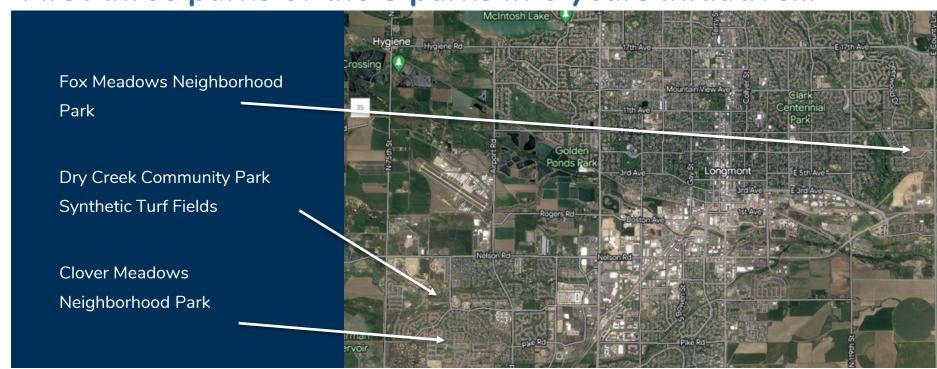

# Fox Meadows Neighborhood Park

- New neighborhood park on a 9 acre parcel in an area not currently served by a neighborhood park. This parcel
  was dedicated to the City of Longmont in 2004 with the Fox Meadows Subdivision.
- Master Planning/Public Input: August 2023-November 2023
- **Design:** November 2023 May 2024
- Anticipated Construction: June 2024 January 2025
- Design/Build contract awarded to ECI Site Construction and Wenk Associates

# Dry Creek Community Park Synthetic Turf Fields

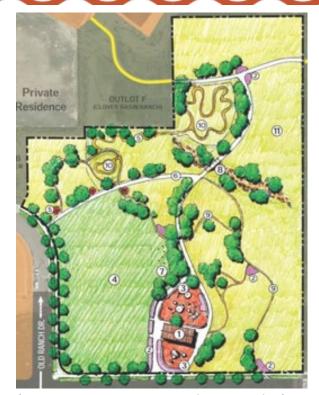
- Challenge: Existing natural turf fields that were constructed as part of Phase 1 of the Dry Creek Community Park in 2012 have continually failed due to high water table and soil salinity causing the fields to go unused.
- **Solution:** Replace with synthetic turf fields, which will be the first fields of this kind in the City of Longmont.
  - Multi-use fields with striping as needed based on use
  - New field lighting
  - Increase usability for multiple sports
- **Design:** August 2023 March 2024
- Anticipated Construction: April 2024 December 2024
- Design/Build contract awarded to ECI Site Construction and Wenk Associates

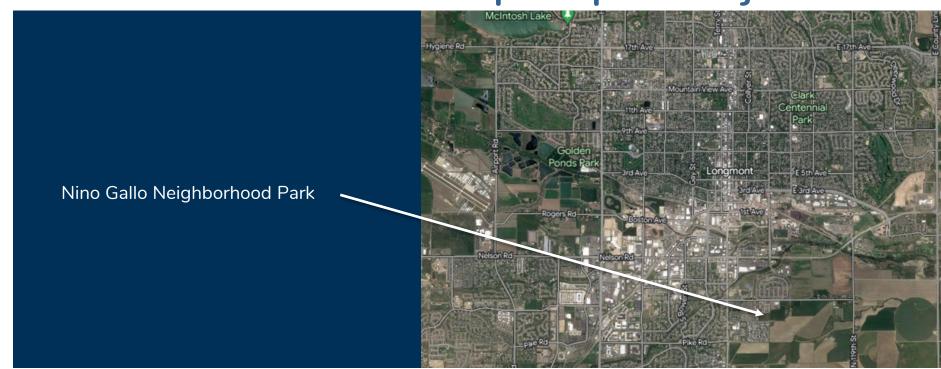
### Clover Meadows Neighborhood Park

- New neighborhood park on a 6.84 acre parcel in SW Longmont that is amidst several new neighborhood developments.
- Master Planning and public engagement: Occurred in 2019.
- Design: August 2023 January 2024
- Anticipated Construction: January 2024 October 2024
- Park elements:
  - Restroom
  - Picnic Pavilion
  - Bike Skills Track/Single Track Loop
  - Playground
  - Open/Flexible-Use Lawn
  - Concrete Trail
  - Soft Surface Trails
  - Natural Open Space
- Design/Build contract awarded to ECI Site Construction and Wenk Associates

- Master Planning and public engagement: Occurred in 2019.

- Anticipated Construction: October 2023-Fall 2024
- Park elements:
  - Four Pickleball Courts
  - Basketball Hoop
  - Playground
  - Disc Golf
  - Restroom
  - Picnic Pavilion
  - Dog Park with Shelter
  - Natural Grasses/Irrigation at Outlot D
- Design: Wenk Associates
- Construction: TBD

Phase 13 (green) eastern terminus will link to St. Vrain State Park's existing trail.

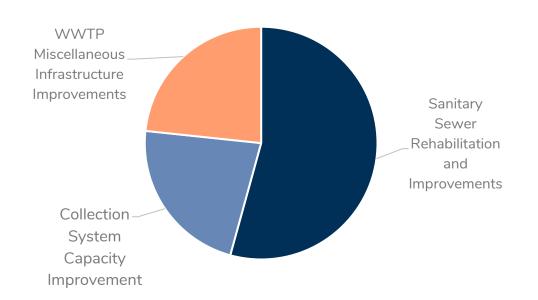

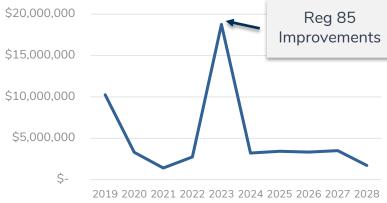

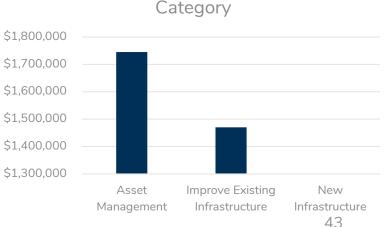

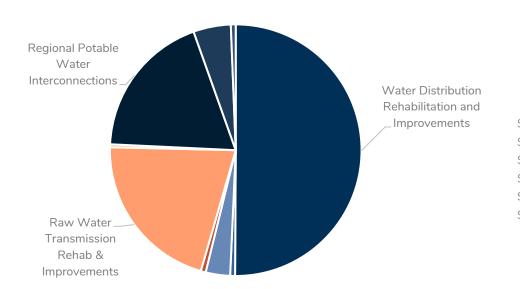

# Transportation (Street Fund)



### 2024 Proposed Street Fund Budget



- \$31,192,272 in expenditures
  - \$29,807,163 in revenues
  - \$1,385,109 contribution from fund balance
- 42.913 FTE
  - Includes 4.94 in new FTE



### 2024 Proposed Street Fund Vision Zero Investments

- 4 new positions
  - Alternative Transportation Planner
  - Senior GIS Mapping Technician
  - Neighborhood Resource Specialist
  - Transportation Engineering Assistant
- \$150,000 for consulting work
- \$400,000 included in TRP011 (Transportation System Management) capital improvements





### 2024 Proposed Street Fund Transit Program Investments

- \$1,205,760 in total
  - \$138,700 for FLEX Bus Program
  - \$45,000 for Access-a-Ride
  - \$150,000 for VIA
  - \$224,000 for RideFree Longmont
  - \$648,060 in new funding proposed to support Micro Transit System

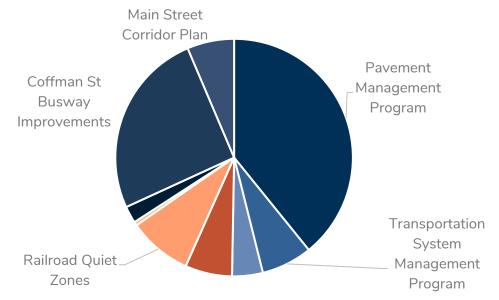

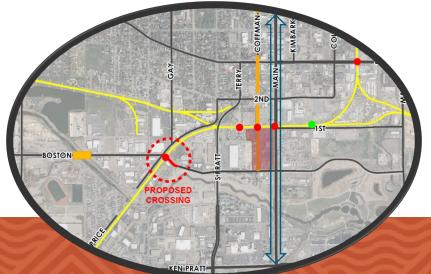

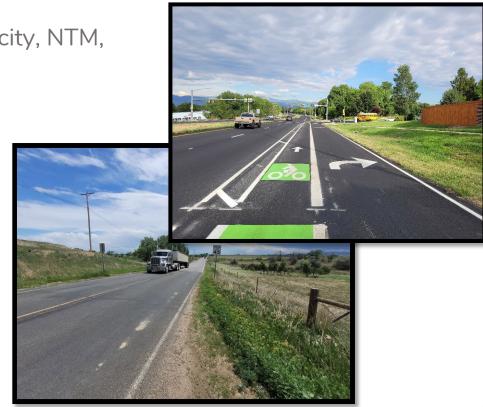

# Affordable and Attainable Housing Funds

### Affordable Housing Fund

- \$2,836,543 in total, including:
  - \$1,206,543 in GeneralFund transfers
  - \$275,000 in Special
     Retail Marijuana Tax
     revenue
  - 3.34 FTE





### **Attainable Housing Fund**

- \$1 million proposed in 2024 General Fund transfers to fund
  - \$250,000 per year existing ongoing General Fund transfer
  - \$350,000 additional proposed ongoing General Fund transfer proposed
  - \$400,000 additional one-time General Fund transfer proposed
- 1.6 FTE
  - Includes a new Homeownership Specialist

### Proposed Increase to Administrative Caps

 10% - Current cap for Affordable and Attainable Fund revenues used for program administration



- 20% Proposed increased cap
  - Decreasing federal funding sources
  - Organizational realignment
  - Additional administrative capacity needs to pursue additional funding and administer new programs
