Attachment 3
Premises Sketch or Diagram §

§ Here attach a sketch or diagram showing (for all classifications of sexually oriented businesses):

1. the configuration of the premises.
2. a statement of total floor space occupied or to be occupied by the business.
3. the place at which the permit, if granted, will be conspicuously posted.
4. orientation to the north or to some designated street or object.
5. a designated scale to which the sketch or drawing is drawn or
6. marked dimensions sufficient to show the various internal dimensions of all areas of the interior of the premises to an accuracy of plus or minus six (6) inches.

In addition, for all classifications except adult motel, the sketch or diagram must:

7. show the location of one (1) or more manager's stations. (A manager's station may not exceed 32 square feet of floor area).
8. show the location of all overhead lighting fixtures.
9. designate any portion of the premises in which patrons will not be permitted.

A professionally prepared diagram in the nature of an engineer's or architect's blueprint is not required; however, each sketch or diagram must comply with the foregoing requirements listed above.

The City may waive the foregoing sketch or diagram for renewal applications if the applicant adopts a sketch or diagram previously submitted and certifies that the configuration of the premises has not been altered since its preparation.
