- 3. Approval of the agenda and previous meeting minutes:** Motion made by Terrie Rives, seconded by Rita Gee to approve unanimously. Agenda approved, no previous minutes were available.

- 6. City Council Update:** Mayor Joan Peck discussed the ongoing work for the Quiet Trains – BNSF now has been cooperating with Longmont to get the areas finished, including work on some of the roads and gradually getting to all of them. Council is reviewing what revenue could be brought in for the improvements to the Longmont Airport that have never been updated in 80 years. The FAA only gives funds if we have local “matching” funds to contribute. There is a lot of support for continuing to work on the Front Range Passenger Rail that will ultimately run from Pueblo to Fort Collins, with projected opening in January 2029. There is also very serious interest at both ends from New Mexico and Wyoming to connect to the train.
